Reservations:

Airfare, Departure Taxes, surcharges, and government fees are not part of the tour price and are the sole responsibility of the traveler.

Changes in plans: For changes you make to your reservation from deposit to 90 days prior to departure that affect the arrival city, accommodations and/or passport name changes, a \$50 per-person administrative charge applies. Changes to departure date or destination prior to departure may incur cancellation fees.

All changes are subject to availability and cannot be guaranteed.

Cancellations and Refunds:

If you must cancel your trip, you must do so in writing. Cancellation refunds will be calculated as of the date we receive your written cancellation.
